

mission?

Once these questions have been answered, the goals and objectives of the organization can be determined. Goals and objectives support the mission statement of the organization. A statement such as "to increase membership by 10% by December 31 1998" is an example of an objective.

The third step in the process is the formulation of the strategy, keeping in mind the operating environment, organizational capabilities and organizational direction. What are we, as leaders and members of the organization, going to do? How do we determine the proper allocation of organizational resources to the direction we have selected?

There is no easy answer to this question, and this task is by far the most difficult since our organization and the courts operate in an ever-changing environment.

Nonetheless, the task must be accomplished. Planning, research, "...what if...?" scenarios are but some of the tools available for this task.

The fourth step in the process is the implementation. If the preceding steps have been thoroughly and honestly performed, this step becomes almost anti-climatic. Again, it can be tedious and timeconsuming to develop an implementation plan, but it is not difficult.

The last step is the establishment of control mechanisms. A feedback process must be developed so that managers at all levels can determine if the implementation plan is being properly executed. Key indicators need to be established and reporting systems established.

The principles of strategic planning are very straightforward. There is no "black magic" associated with the process. Like so many other things that we do, perseverance and attention to detail are often the major differences between success and failure.

In early 1995, a concept was developed for the long range planning committee to address, in a comprehensive manner, in conjunction with the NCACC Membership, a methodology for identifying areas for improvement and development in both the NCACC and in the appellate court sys-

The concept envisioned a three-part approach, each part to be implemented at each of three sequential NCACC annual conferences.

The first part, in San Antonio, in 1995, focused on the basic principles involved in long range planning. This presentation was designed to familiarize participants with the key elements and processes involved in long range planning. The formal presentation was followed by a hands-on workshop, wherein conference participants were asked to identify the strengths, weaknesses, opportunities and threats as they pertained to both the NCACC and the appellate court systems.

Part two, in 1996 in Des Moines, focused on prioritizing these attributes by having conference participants rank order the relative importance of each attribute. Of interest is the fact that the high priority issues were unequivocally distinguished from the lower priority issues.

So that we will be prepared, we ask everyone to spend some time reviewing what we have done so far. Please take time to read this information and make plans to participate in our long range planning fail." sessions on Tuesday and Thursday. On Tuesday, other breakouts will be

offered, but you will have an opportunity to participate in all four sessions on long range planning. We ask you to dedicate yourself to this important endeavor. Everyone's input and participation is important.

So now let us review and prepare.

Whether we call it future's planning, long range planning, strategic planning or strategic management, the desired end result is the same. We need to ensure that our organization (whether NCACC Court) is as matched to its environment as possible on a continuous basis.

The process for doing so is not complicated, but it can be tedious and time-consuming, if the procedure is to be done correctly.

If we are to match our organization to the environment, then clearly we need to perform an analysis of both. This is the first step in the process.

The environment in which our organization

functions is largely beyond our control. Such things as politics, religion, social issues, technology, ethics, economics, and the natural environment, can have profound and deeply lasting influences on what organizations can and cannot achieve.

a long range plan An evaluation of the operating envimay be a long ronment will reveal many potential opportunities for success as well as multiple potential threats which can result in failure.

> An organization also has an internal environment, which is characterized by strengths and weaknesses. Some organizations are clearly able to do some things better than others.

> An organization's top managers, therefore, must determine the external environment's opportunities and threats, and attempt to maximize the potential for success by concentrating on the opportunities taken together with the organization's strengths, while minimizing the potential for failure, i.e., by staying away from threatening situations or by realizing and being willing to admit, the existence of organizational weaknesses.

> Once the opportunities, threats, strengths and weaknesses have been identified, the second step is the determination of the organization's direction. The basic question to be asked is why does the organization exist? What is the organization's purpose? What is its

All committee chairs thanked their members for service.

Finance and Investment Committee: Treasurer Danielle Schott (LA) presented a report consisting of seven exhibits (attached). She specifically recognized the return of \$7,806.56 to the Conference by Keith Richardson, host of the Twenty-third Annual Meeting in Des Moines, Iowa, in 1996.

The fund balance on June 30, 1997, was \$109,681.19.

Awards Committee: Chair Noël Dessaint noted that awards will be announced and presented at the annual banquet.

Bylaws Committee: President Marilyn Graves announced that the amendment to Article VII of the Bylaws which changes the composition of the Public Relations Committee was submitted to the Executive Committee by April 1, 1997, and published in *The Docket*. A further proposed amendment to Article VII of the Bylaws which would create a Technology Committee was submitted to the Executive Committee on August 2, 1997, and has not been published in *The Docket*.

John Wilkerson moved to suspend Article XI, section 1, of the Bylaws so the Technology Committee amendment can be considered by the membership at this meeting. The motion was seconded and carried by a vote of seventy-five percent of the members present and entitled to vote.

Chair Martin Brownstein (NY) presented the Bylaws Committee recommendation to amend Article VII in the following manner as published in *The Docket*:

- Delete Article VII, section 3, paragraph (h);
- 2. Renumber paragraphs (i) through (n) of Article VII, section 3, to paragraphs (h) through (m);
- 3. Add a new paragraph (b) to Article VII, section 4, to read as follows:

The Public Relations Committee shall be composed of three members of the conference. Each year the Vice-President shall appoint a member of the conference to serve for a period of three years. Except as provided below, the senior member of the committee shall serve as the chair.

The Public Relations Committee shall gather news items promoting conference members and their accomplishments for publication in professional journals and local newspapers.

The Public Relations Committee shall function as a select committee, commencing at the close of the business meeting at which this provision is approved. At that time, the Vice-President shall select one member to serve for three years, the President-Elect shall select one member to serve for two years and who shall serve as chair during his or her second year, and the immediate Past-President in consultation with the President shall select one member to serve for one year and who shall be the first committee chair.

Chair Martin Brownstein presented the Bylaws Committee recommendation to amend Article VII, Section 3, to create a Technology Committee as follows:

(n) <u>Technology Committee</u>. The Technology Committee shall provide technical support and advice to appellate court clerks and their staffs and coordinate electronic communications between the Conference and other organizations.

The amendment carried.

Convention Assistance Committee: Chair Joyce Goldsmith (AZ) outlined the role of this committee in assisting the host clerk.

Long Range Planning Committee: Chair Mike Yerly (CA) reported that the Long Range Planning Committee recommended formation of a Technology Committee. Progress has been made in setting up an NCACC Web page in conjunction with the National Center for State Courts. The newly-created Technology Committee will assume implementation and maintenance of the Web page. The Long Range Planning Committee continues work on a membership questionnaire regarding conference funding.

Membership Committee: Chair Tom Granahan (DC) announced that the NCACC had eighteen new members in 1995-1996 and twenty-three new members in 1996-1997. Eighteen of those twenty-three new members were in attendance in Point Clear.

Nominating Committee: Chair Ella Williams (MI) thanked the membership for participating in the nomination process. The 1997-1998 nominations are: Leslie Gradet (MD), Vice-President; Kenneth deBlanc (LA), Treasurer; and Executive Committee members Kathleen Kempley (AZ), Sherie Welch (GA), and Ed Smith (MT).

President Marilyn Graves recognized the presence of Justice Jon Wilcox, Wisconsin Supreme Court, who serves as the American Bar Association/Appellate Judges' Conference liaison to the Committee on Continuing Education.

Pictorial Directory Committee: Chair Ken deBlanc (LA) requested that everyone submit a biography and a photograph. Any changes submitted by April, 1998 will be included in the next directory.

**Program Committee:** Chair Ed Smith (MT) noted the different format this year with earlier starting times. Ed reviewed the programs scheduled for the week.
