From the President's Desk

Rory Perry (WV)

An effective appellate court clerk not only understands court process and procedure, but must also be able to communicate clearly about the system used in his or her court. This skill requires an adept understanding of the audiences we face in situations like: answering a "quick question" from a Justice; writing a memo to the administrative office; giving a speech to lawyers; answering an e-mail inquiry about procedure; answering a letter from a pro se litigant; being asked to

weigh in on a point of procedure by a law clerk or staff counsel; telling a lawyer that he is wrong, or late; working with a committee on drafting rules; providing feedback on business process to a technology developer; teaching a new staff member about your system; and, as we will all practice often in Seattle, explaining your system to a colleague who has a different system.

I believe there is a lot of value in the practice of explaining your system to someone else. Let's say you have a cabin on the river that is big enough to share with friends. It's remote, but you've driven there a hundred times while finishing the place. The first time you give directions to your friend from out of town, what seemed so familiar to you is quite hard for your friend to follow. Your friend arrives late, all in a bluster, saying, "Why didn't you tell me about that creek crossing!" So you refine your directions. You later learn to change them for winter because the scenery is different. All the while, you and your friends become experts in finding the cabin no matter the weather or season.

These days, being able to describe your system clearly is a very important skill. Due to the level of increasing refinement in technology and automation, many of us are spending more time in meetings going over long lists of document types, event types, workflow diagrams and the like. During this process, it can feel like you are giving directions to someone from out of town who has never seen a car, doesn't know the rules of the road, and thinks he's headed for

the swimming pool rather than a garage on the other side of town. That's one reason why we all need to practice this skill.

Every year since 1973, in wonderful locations around the country, the NCACC has provided appellate court professionals with a singular forum to practice this skill. Please come to the conference in Seattle with an issue you are working on. During the conference, find someone from another jurisdiction, with a different system, and tell them about your

issue. Listen carefully while they respond with an insight about their own system. If you do this enough, you are sure to have an "a-ha" moment. It happens for me every year.



NATIONAL CONFERENCE OF APPELLATE COURT CLERKS THIRTY-NINTH ANNUAL MEETING

Charleston, South Carolina Sunday, July 29, 2012 through Thursday, August 2, 2012

Call to order:

President Marilyn May called the Thirty-Ninth Annual Meeting of the National Conference of Appellate Court Clerks to order at 12:25 p.m. on Sunday, July 29, 2012. She welcomed everyone to the conference, and introduced the host of the conference, Dan Shearouse. Dan welcomed everyone to Charleston, and shared comments about the planned activities for the week. He then introduced his staff, whom he thanked for their help and hard work in getting everything ready for the conference. David Beach (VA) was introduced as the parliamentarian for the meeting, and confirmed that a quorum was present.

Gavel:

Marilyn held up the NCACC gavel and shared the history with the membership:

"This gavel and sounding block was made by Paul W. Mims of Longleaf Heart Pine Wood which was from the desk of the South Carolina Supreme Court. This desk was located in the State Capitol Building prior to 1886.

Presented to Frans J. Labranche, Jr., and all future Presidents of the National Conference of Appellate Court Clerks at the 1987 Annual Conference, Hartford Connecticut, by Reba D. Mims, Clerk, South Carolina Court of Appeals, and member of the Executive Committee of the NCACC 1985-1987.

Paul W. Mims passed from this life on April 15, 1989. Reba W. Mims hosted the conference in Charleston, South Carolina August 6-11, 1989."

Roll Call of States:

Secretary Sherry Williamson (TX) called the roll of states, recognizing each person registered and present. President May then welcomed the new members in attendance.

Introduction of Officers:

President May introduced the officers and members of the Executive Committee.

Approval of minutes:

Colette Bruggman (CA) moved that the minutes of the 2011 Annual Business Meeting in Annapolis, Maryland be approved; Joe Lane (CA) seconded the motion; motion carried.

Committee Reports

Awards Committee: Steve Lancaster (IN) reported that the awards were ready and would be announced at various times during the week. He requested nominations for the Trailblazer Award, which would also be announced at the banquet.

Bylaws Committee: Danielle Sheff (IN), on behalf of Joe Stanton, Chair (MA), introduced and thanked members of the committee: Penny Miller (ND), Fritz Ohlrich (CA), James Pelzer (NY), Doug Robelen (VA) and Kevin Smith (IN) (Executive Committee Liaison). She congratulated Fritz Ohlrich (CA) on his retirement, and thanked him for his years of dedicated service on the Bylaws Committee. Danielle reported that last year the membership had voted: 1) to expand regular membership to include tribal and international appellate court administrators; and 2) against retired members serving on the Executive Committee. Both proposals were published in the April 2012 issue of The Docket. The Bylaws Committee is proposing three amendments to the Bylaws:

- 1) To strike certain language in Article III, §1(b) for the purpose of making the language consistent with the 2011 amendments to paragraphs (a) and (c). Specifically, the proposal is to strike the phrase "in any federal, state, commonwealth, or District of Columbia court system, and in the court systems of United States territories and possessions." If amended, the Bylaw Article III, § 1(b), would read:
- (b) <u>Retired members</u>. Retired membership shall be open to all retired clerks, assistant clerks or deputy clerks, or other similar positions bearing different titles of courts of last resort or intermediate appellate courts. in any federal, state, commonwealth, or <u>District of Columbia court systems</u>, and in the court systems of <u>United States territories and possessions</u>.
- 2) To change the name of the "Contract Committee," as it appears in Article VII, § 3(c)(16), to "Contracts Committee." If amended Article VII, § 3(c)(16) would read:
- (16) <u>Contracts Committee</u>. The purpose of this committee is to review any contract referred to it by the President or the Executive Committee. The committee shall report its recommendation to the President and the Executive Committee.
- 3) To delete the language "and the Public Relations Committee" from Article VII, § 3(c), second sentence. If amended Article VII, § 3(c) would read:
- (c) <u>Composition</u>. Except as noted in (2), (3), (4), (6), (10) and (12) of this subsection, standing committees shall consist of no more than nine members, one of whom shall be designated by the President as the Chairperson. The membership of the Program Committee shall also include a Vice-Chairperson appointed by the President-Elect. The term of the members, the Chairperson and, when applicable, the Vice-Chairperson, of a standing committee shall be one year. The Executive Committee, upon request of the President or the committee Chairperson, or upon its own initiative, may remove a member of a standing committee for good cause.

Marilyn May brought the amendments to the membership for a vote:

- 1) Article III, § 1(b) -- Kevin Smith (IN) moved to accept the amendment; Steve Lancaster (IN) seconded; motion carried.
- 2) Article VII, § 3(c)(16) -- Jim Pelzer (NY) moved to accept the amendment; Sandra Skinner (MO) seconded; motion carried.
- 3) Article VII, § 3(c) -- Terry Lord (MO) moved to accept the amendment; Rex Renk (MT) seconded; motion carried.

Colette Bruggman (CA) called a point of order, and requested that the minutes reflect these amendments were previously published in *The Docket*.

Convention Assistance Committee: Deena Fawcett (CA) thanked the members of the committee: Polly Brock (CO), Tom Hall (FL), Petra Hulm (ND), Matt Kiernan (NY), Penny Miller (ND), Kevin Smith (IN), Les Steen (AR), Renee Townsley (WA) and Ruth Willingham (AZ). Deena offered special recognition to Les Steen (AR) for his continued efforts in putting together the Hospitality Suite for the conference. Deena reported that the volunteer schedule was finalized to assist the host throughout the conference; the committee members assembled the binders and bags for each conference attendee; assisted with registration, the art auction, loading the buses for the excursions, and anything else that is needed during the conference.

Contracts Committee: Bill DeCicco (DC), on behalf of Chair Kris Frost (OH), reported that the committee had reviewed the host contracts for Richmond 2014 and Snowbird 2015. The committee's recommendations have been submitted to the hosts and to the Executive Committee.

Education Fund Committee/Finance and Investment Committee/Treasurer's Report: Irene Bizzoso (PA) reported that the Treasurer's Report was published in the June 2012 issue of the The Docket, but also had updates which were available on each table. She stated that through all the concerted efforts of the membership, Executive Board, last year's vendor chair, and the current President, there is a reported net gain of \$41,422.69. Of this net gain, approximately fifty percent came from the fundraising efforts for the Education Fund, and the successful vendor show last year also contributed largely to the increase in funds. There is a large amount of cash in the account, and the Executive Committee voted to transfer a portion of the cash to a Certificate of Deposit and this will be transferred soon. Irene stated that NCACC is fiscally sound and is doing better than it has in several years, and thanked everyone for their efforts in making this happen. Terry Lord (MO) inquired about the CATO funds that were still showing in the NCACC funds. Irene deferred to Blake Hawthorne (TX), because he has been doing research on the best method to remedy this situation. Blake stated that the cy pres doctrine does not apply, because NCACC is a 501(c)(3) organization, but CATO is not. Blake stated that this is an odd situation, because CATO does not have its own legal identity and cannot legally dissolve. He sug-

gested sending out a notice to the CATO members that NCACC would be using these funds for educational purposes, since CATO is defunct. Blake does not feel that anyone is due a refund. Marilyn May stated that the Executive Committee is still reviewing the option and will work to resolve the situation. She reported that there is \$18,000 in CATO funds.

Membership Committee: John Moyer (PA) thanked the members of the committee: Susan Clary (KY), Chris Crow (LA), Eileen Fox (NH), Joseph Lane (CA), Terry Lord (MO), Mark Neary (NJ), Danielle Schott (LA), and Eileen Fox (NH) (Executive Committee Liaison). John reported that the committee met by email this year, and worked closely with other committees: Publications – worked to bring the members' pages current in the NCACC directory; Public Relations – worked on the plan of expanding the membership to include tribal and international appellate court administrators; The Docket -- several articles have been written about members retiring and about new members. The National Center sends out monthly reports on the membership, and the current total is 197. There are still several states that do not have any members in NCACC, and this is fertile ground for recruitment. He suggested that this would be a nice effort for next year's committee.

Nominating Committee: Trish Harrington (VA) thanked the committee members: Debbie Autrey (TX), Irene Bizzoso (PA), Susan Clary (KY), George Geoghegan (KY), Joseph Lane (CA), Amy Reitz (OH), Mike Richie (OK), Christie Cameron Roeder (NC), and Blake Hawthorne (TX) (Executive Committee Liaison). Trish reported that the Committee is offering the following nominations and introduced each one:

Secretary -- Sherry Williamson (TX)
Executive Committee Members -- Eileen Fox (NH)
Tracie Lindeman (NV)
Heather Smith (IN)

The pictures and biographies of each nominee were published in the June 2012 issue of The Docket. Membership will vote on Thursday.

Past Hosts Committee: Tom Hall (FL) reported that the committee is working on preparing either a standardized contract or a Request for Proposal, which will be used in negotiating hotel contracts for future conferences. He stated that the contracts the hotels are offering are extremely detailed and give no concessions that are needed for the conference. The committee did have two Requests for Proposal for previous conferences that were submitted to the Executive Committee for review. Next, Tom reported that the committee has been asked to review the possibility of the Past Hosts Committee becoming a permanent committee, and if so, what guidelines should be implemented. It has been recommended that this committee should assist the host prior to the conference, and then the Convention Assistance Committee would take over assisting the host as the conference starts. No formal action has been taken on this proposition, and Tom requested that it be carried over for next year's committee.

Past Presidents Committee: Bill DeCicco (DC) reported that the committee was tasked with two projects this year:

- 1) Redesigning and updating the NCACC website The committee submitted a request to the National Center for State Courts for a grant. The cost for this project was estimated to be \$34,000. The State Justice Institute grant would provide 50% of this cost, while NCACC would provide the other 50%, with 80% being in-kind services and 20% in cash (around \$3,400). He stated that NCSC should provide an answer within the next week. Bill commended Rory Perry (WV) on his assistance in drafting the technical computer language that was needed for the request.
- 2) A complete review and re-write of the Officers' guidelines -- The guidelines are rewritten, being approximately twenty pages long and outlining specifically the duties for each officer.

Pictorial Directory Committee: Chair Kelly McNeely (LA) reported that the NCACC directory has been distributed to the membership. He stated that every committee reviewed its Bylaws and guidelines, and several changes were made to bring them current. Kelly mentioned that if any member does not have his/her picture in the directory, or if you need a new one, Deena Fawcett (CA) has her camera and will take it for submission to the NCACC directory. Rory Perry (WV) gave the address of NCACC website, where the directory is duplicated online in the "Members Only" portion.

Program Committee: Colette Bruggman (CA) reported that the program schedule is in the conference binder. She thanked Marilyn May for giving her the opportunity to serve as Program Chair, and also thanked the members of the committee: Amy Reitz (OH), Vendor Chair; Irene Bizzoso (PA), Greg Block (DC), Karen Bramblett (PA), Kristen Brown (PA), Eydie Gaiser (WV), Carolyn Taft Grosboll (IL), Mark Neary (NJ), Catherine O'Hagan Wolfe (NY), and Rory Perry (WV) (Executive Committee Liaison). Each member worked as the liaison for a speaker on the program and wrote an article for The Docket. Colette also thanked the

members who agreed to be a speaker for the conference: Tom Hall (FL), Tiffany Shropshire (TX), Blake Hawthorne (TX), Kevin Smith (IN), and Irene Bizzoso (PA); Chris Crow (LA) and Deena Fawcett (CA) for moderating the round-table discussions, and to Jack Simpson and Bernie Bruggman, non-members, for their endless hours of assistance. Colette then reported that there had been a problem with the "Paper on Demand" session to be presented by ImageSoft, Inc. on Monday afternoon. At the outset of planning this session two years ago, the guidelines were laid out to the vendor that this was a plenary session, and no marketing could be involved. Marketing during the education program is against all policies and limited to the vendor showcase session. However, it became apparent that the vendor was still trying to include some marketing techniques in the presentation. The vendor even compiled its own email list and sent out a marketing brochure, wherein the NCACC logo was used. During a conference call the previous day between Marilyn, Colette, Catherine O'Hagan Wolfe, NCACC panel member, and the vendor, parameters were again laid out regarding the importance of this being an education program and no marketing would be permitted during the session. After the call, it appeared that all issues were resolved. Colette reported that there are two programs that will be videotaped and placed on the NCACC website. Additionally, the materials in the conference binder have been provided electronically and will be posted in the "Members Only" portion of the NCACC website. She encouraged each conference attendee to complete the evaluation for each session and place them in the appropriate boxes. Colette stated that the vendor show will have the passport format again this year.

Publications Committee: Rory Perry (WV), on behalf of Les Steen (AR), reported that all issues of The Docket were published on time and all requirements were met. He thanked the committee members: Paula Garcia (CA), Trish Harrington (VA), Kevin Lane (CA), Judy Pacheco (WY), and Joe Stanton (MA). Rory specifically thanked Lillian Richie (LA) and Brenda Stephens (LA) for their hard work and assistance in preparing each issue of The Docket.

Public Relations Committee: Kevin Lane (CA) thanked the members of the committee: Karen Bramblett (PA) and Rachelle Resnick (AZ). The committee had two major accomplishments this year: 1) Two of the sessions during the conference will be vide-otaped and placed on the NCACC website. When the segments are running on the website, an email will be sent out on the listserv and notification placed in The Docket as well; 2) Amendments were made to the Bylaws regarding the recruitment of new members of the tribal and international appellate court administrators. A new brochure has been developed for this purpose.

Special Awards: Marilyn May stated that she and the Executive Committee would like to give special recognition to members who contribute to NCACC year after year doing somewhat thankless jobs. The members who received the special awards are:

Deena Fawcett (CA) made a motion that the meeting be adjourned until Thursday, August 2; Steve Lancaster (IN) seconded the motion; motion carried.

President May announced at 1:40 p.m. the adjournment of the meeting until Thursday at 11:00 a.m.

Tracie Lindeman (NV) made a motion to approve the resolutions as read; Deena Fawcett (CA) seconded; motion carried.

Scholarship Committee: Ruth Willingham (AZ) thanked the members of her committee: Debbie Autrey (TX); Julio Castillo (DC); and Sherry Williamson (TX), (Executive Committee Liaison). She reported that four applications for scholarships were accepted and reviewed. Upon the review being completed, two scholarships were awarded. Ruth encouraged everyone to apply for financial assistance for the future annual conferences.

Site Selection Committee: Marilyn May stated that Matthew Kiernan (NY) was the original chair of the committee, but changed jobs. At that time, Vickie Van Lith (FL) became chair. The other members of the committee are: Debbie Autrey (TX); Susan Clary (KY); Paula Garcia (CA); Carolyn Taft Grosboll (IL); M. C. Hackney (NC); Donna Humpal (IA); Kelly McNeely (LA); Dan Shearouse (SC); and Laura Roy (MO), (Executive Committee Liaison). The site selected for the 2015 conference is Snowbird, Utah. Lisa Collins (UT) will be the host, and is working on getting the contract finalized.

Strategic Planning Committee: Karen Bramblett (PA) served as chair, and members of the committee were: Bill DeCicco (DC); Steve Lancaster (IN); Penny Miller (ND); Rory Perry (WV); and Deena Fawcett (CA), (Executive Committee Liaison). This committee did not have any charges this year. They reviewed the Bylaws and guidelines, with no recommended changes.

Technology Committee: John Olivier (LA) thanked the committee members: Kris Frost (OH); M.C. Hackney (NC); Kevin Lane (CA); Susan Davis Morley (FL); Danielle Sheff (IN); Joe Stanton (MA); Renee Townsley (WA); and Blake Hawthorne (TX), (Executive Committee Liaison). He reported that the committee was charged with the following:

1) To create a survey for those attending the conference and also those who cannot attend the conference, obtaining feedback upon viewing the videos of presentations and other conference materials, which are posted to the NCACC website –

John stated that the first job is to make sure people are aware the website has the information posted. Next, the committee is reviewing a couple of methods to create the survey. One option to be considered is to have the NCACC logo appear on the survey without being required to pay a fee for using the logo.

2) To pass along all Technology Committee materials and resources from one year to the next year –

The committee is in the process of creating a binder for this purpose.

3) To create an information tab on the NCACC website –

Upon the recommendation of the Public Relations Committee and approval by the Executive Committee, a link will be placed on the website for "Public Information." This link will also include press releases to inform the public about what is happening in NCACC.

4) Facebook -

John reported that the topic of NCACC having a Facebook page is still under consideration by the Executive Committee.

Adoption of Committee Reports: Bill DeCicco (DC) moved to accept all of the Committee Reports; Chris Crow (LA) seconded the motion; motion carried.

Special Awards: Marilyn May stated that during the business meeting on Sunday, several Special Awards were presented to members who contribute to NCACC year after year doing somewhat thankless jobs. She announced that there was one more Special Award to be given to Les Steen (AR). However, Les had to leave the conference early and was not present to accept the award. Marilyn thanked Les for all his hard work and dedication in serving as Chair of The Docket Publication Committee. All members joined in applause, showing their appreciation.

Trailblazer Award: Steve Lancaster (IN) presented the Trailblazer Award to Polly Brock (CO). To everyone's amusement, Polly shared the story of her trip to the conference.

President's Remarks: President May stated that NCACC really is in a good place financially. She attributed this sound fiscal picture to the work of past presidents, Susan Clary, Ed Smith and Bill DeCicco. Upon reviewing the finances in past years, Marilyn noted that the organization had a high balance of \$195,000 in December 2007 and a low balance of \$130,000 in February 2010. At that point in February 2010, a "crisis mode" set in and the Executive Committee tightened their belts and became very fiscally conservative. As previously reported, the balance in May 2012 is over \$224,000, which is probably the highest balance ever achieved for NCACC. She next reported on the unrestricted funds: after subtracting the CATO funds of \$18,000 and Education Funds of over \$95,000, in 2005, there was a high balance of \$104,000, with a low balance of \$50,000 in 2008. At the present time, (Continued on page 14)

the unrestricted funds exceed \$109,000. Marilyn stated that due to the generosity of Dwight Opperman, the stewardship of Susan, Ed and Bill, and the donations from many members, the Education Fund now has a balance of \$95,104.20. This will enable the organization to develop great educational programs for future conferences.

Marilyn reported that the process of handling the CATO funds of \$18,000 is being researched. Blake Hawthorne (TX) is developing a plan to remedy this situation.

Marilyn stated that one year ago, the vote was made to expand the NCACC membership to tribal, Canadian or any international courts. The Public Relations committee has been working on a program to advertise our availability to those people, and the committee will be taking the necessary steps to reach out to new members.

Marilyn stated that her big goal this year was to expand the availability of the conference materials to members not able to attend the conference and staff members. The Technology, Public Relations and Program Committees worked very hard to make this goal a reality. Two of the programs were videotaped, and Rory says the videos and conference materials will be on the website in approximately a month. She shared her appreciation to all the people who made that happen.

Marilyn then stated that the idea of pursuing a website grant began under Susan Clary's (KY) direction, and then Bill DeCicco (DC) and Rory Perry (WV) completed the request. NCSC should announce their decision within the next two weeks. This grant will enable NCACC to make needed improvements to its website.

Marilyn thanked everyone for their part in keeping the organization vibrant and strong, for helping to provide the education we need, and for the support all members have with each other throughout the year.

2012 Host Presentation: Marilyn May and Tom Hall, along with great assistance of Vickie Van Lith, invited everyone to attend the 2013 conference in Seattle, Washington. The dates of the conference are August 4 – August 9, and will be held at the Seattle Renaissance Hotel. The hotel is a great location, within walking distance of several restaurants and shopping locations. Prizes were given away upon providing the correct answers to trivia questions. Marilyn and Tom said the West event will be held at the Boeing Flight Museum, and the LexisNexis event will either be at the zoo, a cruise or the Science Center at the Space Needle.

There being no further business, Irene Bizzoso (PA) made a motion that the meeting be adjourned; Deena Fawcett (CA) seconded; motion carried. The meeting was adjourned at 11:50 a.m. on August 2, 2011.

Delegation Presents the J.O. Sentell Award to Bill Suter in Washington

On May 21, 2013, the 19th Clerk of the Supreme Court of the United States, Bill Suter, received the J.O. Sentell award from the NCACC at a ceremony at his office in Washington D.C. For the past 22 years, Bill has shared his time and talent with NCACC members throughout the country. He has attended every conference, and has always been willing to mentor individual members. He has been a speaker and committee member, and has always contributed selflessly to the Conference, including the organization of a visit to the Supreme Court of the Unites States for NCACC members and their families in 2011.

The Executive Committee created an annual award to recognize distinguished service rendered by the recipient who has contributed in a substantial way to the objectives of the Conference. Known as the "J.O. Sentell Award", it was first presented at the 1979 annual meeting held in Monterrey, California to Mr. J.O. Sentell, one of the founding members of the organization. In 1984, the award was presented to Mr. Alexander Stevas, the 17th Clerk of the Supreme Court of the United States.

In light of the fact that Mr. Suter is retiring at the end of August and will not be attending the conference in Seattle, the Executive Committee elected to present the award to him early, at his office in Washington. The President, Rory Perry (WV), was joined at the ceremony by two past presidents, Bill DeCicco (DC) and Christie Roeder (NC), and two members of the Executive Committee, Irene Bizzoso (PA) and Blake Hawthorne (TX). In addition, Deputy Clerk Cynthia Rapp (DC) was present, along with other Supreme Court staff. After the award was presented, Mr. Suter made gracious remarks thanking the conference, and emphasizing the benefits to his court of being a member for 22 years. His remarks were videotaped and will be shared with members at the conference in Seattle.

As many of you may know, Mr. Suter is an avid fisherman. In order to mark the occasion of his retirement, several members of the NCACC joined together to purchase a custom, handmade bamboo fly rod and case. Both items were inscribed specifically for Bill Suter from the NCACC. Mr. Suter was quite surprised and appreciative. We wish him all the

Marathon Monday in Boston, Massachusetts By Joseph Stanton (MA)

Thanks very much for including the information in The Docket on my daughter's postcards for class. Her class achieved its goal of receiving a post card from each of the 50 States! The students and teacher were thrilled when the 50th card arrived because it was the first time the teacher had completed her annual project in several years of trying - thank you everyone for sending in the cards. My daughter thinks around 40 states sent a card to her attention - the NCACC is amazing!

I have her hurt foot to thank for us not being at the finish line when the explosions occurred. On Marathon Monday (which, as I told the kids that morning, is one of the two best days in Boston - it's officially Patriot's Day, a holiday when we get to see the Red Sox and Marathon back-to-back, one block from another, usually on a beautiful sunny day after a long winter, while the other day is July 4th watching the Pops play on the Esplanade), I had tickets to attend the Sox game, first pitch at 11:05, then we would watch the runners. But the prior day my daughter hurt her foot in an Irish stepdancing competition and could not walk, so she stayed home.

With my fiancé (yes, on April 6 I proposed to a Yankees fan at home plate of Fenway Park - a tale for another day!), we went to the game, where the air was electric and fun filled with everyone's excitement in the Sox-Marathon doubleheader. We left at 1:15 to cheer a friend running through Kenmore Square and then we walked to the finish line so my son could see and experience it for the first time. As we turned onto Bolyston Street, I hoisted him up above the crowded sidewalks so he could see the entire "home stretch," and I will never forget how, as he slowly gazed and absorbed the combined adrenaline and excitement of runners sprinting to the finish line, he smiled ear to ear as his eyes danced at the magnificence of the street lined with smiling spectators cheering the runners amid the decorative flags and balloons. He said it was "beautiful" and he would never forget it. We were on Boylston Street from 2:00-2:30, with my son on my shoulders for the best viewing option as we maneuvered to the finish line.

Since Fenway Park is on one side of the marathon course and no crossing of the street or course is allowed, we stayed on the Fenway side and walked the mile and got as close as we could to the finish line, hoping he could stand near it, but we were blocked by the VIP grand stands just before the finish line. We staked out a spot on the last

corner we could access, which ended up being diagonally across and probably around 10 car lengths from the first explosion.



Thank God we had to leave early to pick up my daughter and get to my parents for my son's birthday party. We left 15-20 minutes before the first explosion, which we heard blocks away. My son immediately asked, "What was that sound?" and, although strange to think, I didn't want to say "explosion" and scare him because it seemed unfathomable. Instead I said a construction truck must have dropped a delivery, while I wondered why there would be construction on a holiday. Fortunately, we caught a train and were out of the area before the security lockdown, still not knowing what had happened. Just before 3:00 p.m., we hopped in my car and were startled because his favorite music station was reporting two explosions at the finish line and people were hurt. We knew it had to have occurred near where we had stood, and it was sickening to consider even without knowing for certain it was terrorism. My son was very shaken Monday afternoon and night, realizing how close we were in time and distance, and quite happy to see his little sister. Fortunately, as 12 year olds do, he rebounded well on Tuesday - thanks in part to an early birthday gift of a replica Star Wars light saber (yes, it look and sounds like the ones in the movies)! We spent the next day thanking my daughter for hurting her foot at the Irish stepdancing feis, the random reason we left the marathon early. If she had been with us, there would have been no reason to leave the finish line when we did on an otherwise perfect day. I keep thinking of the people we wove around on Boylston Street with my son on my shoulders - the happy faces of the Sox revelers, the marathon finishers wearing finisher medals who we congratulated, their families and friends who packed the sidewalks 10 deep cheering and making it almost impossible to walk, and what their moments must have been like after the explosions. It was amazing more people were not killed and wounded. It was a bit surreal walking into the courthouse Tuesday. The street out front was lined with black clothed police and bomb sniffing dogs because a federal building and major train stop is across the way. Just wanted to share this with you, my friends. Thanks for being here to share. I took the day to appreciate and pray for the first responders and the families of those hurt, and to thank my lucky stars for my son's safety, including the luck of a lil' Irish foot.
